As a collective, CARLI adds value to member libraries of all types, sizes, and missions by sharing costs, collections, expertise, programs, products, and services. (CARLI Mission Statement 2018)

Through the combined effort of the CARLI Board of Directors, staff at CARLI member libraries, and the CARLI staff, I am pleased to present this annual report. The report includes the completed CARLI 2020 Strategic Plan and our accomplishments in support of these priorities. The strategic plan outlines our organization's aspirations and defines our understanding of the consortium's focus as we move towards the fifteenth anniversary of CARLI on July 1, 2020. Over the next two years, CARLI will be focused on providing excellence, leadership, innovation, and collaboration consistent with our organizational values:

- Responsiveness to member needs
- Commitment to intellectual freedom, privacy, security of library records, library standards, and open access to information resources

I am grateful to all who have contributed to the development of the strategic plan. The process was tremendously positive for the organization, allowing us time to discuss priorities and expectations, challenges and accomplishments, and to set our sights on how we would like CARLI to look in the future.

As the final strategic priorities evolved, we have used this strategic plan as a template for our work. You will see some of our major accomplishments noted throughout this report. During Fiscal Year (FY) 2018, we also completed some significant administrative tasks, including the completion of CARLI's "Host Institution Agreement between The Board of Trustees of the University of Illinois System and The Consortium of Academic and Research Libraries in Illinois." The new agreement defines the specific roles of CARLI and Illinois, and the relationship and operational details of our organization, including the administrative structure and support, facilities, fiscal oversight, and intellectual property rights.

CARLI resources exponentially increase access for students and faculty across the consortium. When students enroll at a CARLI member organization, they open their worlds far beyond what any one institution could offer. Member libraries cooperate in innovative and creative ways, building deeper, stronger library collections in all formats. CARLI services and programs build and nurture communities of library professionals to support student and faculty scholarship and learning, and improve student success. Large-scale solutions make possible support of all our members' constituents, regardless of each organization's location, type, or size. In short, CARLI is a powerful ally in support of its members' missions. FY 2018 Accomplishments

- Initiated a "CARLI Philanthropy Program" for sponsorship and fundraising activities
- Reconfigured the CARLI Office to accommodate a 30% reduction of office/meeting space and achieve savings
- Collaborated with the Louisiana Library Network (LOUIS) to co-host a webinar on OER from the faculty viewpoint during Open Education Week

GOAL: Provide mechanisms for group collaboration; identify and leverage model programs, initiatives, and ideas

ACTION: Create and/or facilitate opportunities for regional and topical periodic gatherings of CARLI directors and library staff


GOAL: Identify new services/programs that are scalable and replicable

ACTION: Work with committee members to monitor emerging trends and the work of other consortia

GOAL: Leverage the CARLI committee structure to assess and evaluate services and programs.

ACTIONS: Establish a Board liaison to each CARLI committee and task force to provide feedback on programs and services, and to ensure committee efforts are informed by the strategic priorities set by the Board

Periodically review the committee structure to ensure alignment with consortial priorities



FY 2018 Accomplishments

- Hosted 40+ workshops, training events, forums, open houses and webinars; 1377 attendees from 129 member libraries
- Engaged with members and other UI System stakeholders to complete the strategic plan, "CARLI 2020"
- Reconstituted the New Directors' Institute with a mentor network, to develop academic library leadership within the consortium (2018 cohort=12 attendees)
- Instituted a professional development webinar series for CARLI directors
- Digital Collections
 - o 281 collections: 42 member libraries
 - o 2.6 terabytes of images, printed and manuscript materials, and sound recordings
 - o Publishing function for the Digital Public Library of America, the "Illinois Digital Heritage Hub"
 - Harvest of 250,000+ metadata records, including: CARLI Digital Collections including University of Illinois at Urbana-Champaign Content Hub, Illinois State Library's Illinois Digital Archives, Chicago Public Library, Chicago History Museum, DePaul University
- Consortial eBook collection: 3,992 owned titles include 105 coordinated puchases from 38 libraries Usage in FY 18: 17,900+ loans, 10,100+ downloads from 109 libraries
- Administered ILDS (Illinois Library Delivery Service)
 - o 142 daily stops
 - o 1 million items delivered at \$0.49 per item
 - o 24-hour dock-to-dock delivery

FY 2018 Accomplishments

- Received Illinois State Library grants to support adding community colleges to I-Share and to support gathering statistics about e-resources use
- E-resources
 - o Brokered databases for 124 member libraries:
 - 2,773 subscriptions
 - \$14,281,492 total pass-through spending
 - o Offered access to a fully subsidized package to member libraries
 - o Offered SFX link resolver to improve access to resources
- I-Share
 - o I-Share Next Task Force completed the Request for Proposal, which was posted to the state procurement bulletin board. The task force completed evaluations of RFP responses
 - o FY18: provided public access catalog of over 38 million items
 - Over 270,000 items shared among I-Share institutions in FY18
 - o Added five libraries to I-Share for a total of 91 libraries
 - Abraham Lincoln Presidential Library, McHenry County College, Moody Bible Institute, Rock Valley College, and Spertus Institute of Jewish Studies
 - o Released a new version of the VuFind public interface
 - Improved searching capabilities, integration with campus identity management systems for single sign-on features
 - CARLI-written open source code contributed as enrichment to the international community
- Provided outstanding performance of operational infrastructure with near-zero downtime, quick resolution of service issues, and excellent support for all customer services, including I-Share, SFX, and the E-resources selection system

GOAL: Connect CARLI and member library programs and services to student outcomes such as retention and completion

ACTION: Establish a continuing education program to help member libraries assess their impact on student outcomes such as retention and completion

GOAL: Document the value that CARLI creates; articulate to policymakers and legislators how CARLI provides value to the State of Illinois and why it is a good investment of taxpayer dollars

ACTIONS: Measure ROI of services/programs to ensure that financial resources and staff efforts are focused on identified priorities

Innovation

ENCOURAGE INNOVATION IN SKILLS, SERVICES, PROGRAMS, AND ALL ASPECTS OF CARLI LIBRARIES

GOAL: Encourage member libraries to think innovatively about serving students and faculty

ACTIONS: Highlight and promote member library innovations using CARLI communication channels and CARLI events

Convene CARLI groups on specific in-demand topics identified through periodic surveys and other channels

GOAL: Connect institutions that have similar interests/needs by providing opportunities for interaction and collaboration

ACTION: Identify libraries of disparate types and sizes that are uniquely connected to their students, faculty, and communities

FY 2018 Accomplishments

- Established the Institutional Repositories Investigative Task Force to investigate and evaluate the possibilities of a CARLI administered institutional repository
- Established the "Open Illinois" initiative to promote the consortium's activities around open access learning resources
 - o Established Open Educational Resources Task Force
 - o Initiated CARLI's membership in the University of Minnesota's Open Textbook Network through a crowd-funded membership
